# The Vicente Teves Locsin, Jr. Research and Scholarship in Nursing Award

## AWARD TO ADVANCE THE THEORY OF TECHNOLOGICAL COMPETENCY IN NURSING



The Vicente Teves Locsin, Jr. Award for Research and Scholarship in Nursing is established to promote dissemination of research and other scholarly works focused on advancing the middle-range theory of *Technological Competency as Caring in Nursing*. This award, established by Dr. Rozzano C. Locsin, is given in honor of his father whose guiding wisdom directed his pursuit of a career in nursing. As a result, Dr. Locsin was the first Filipino graduate of the Doctor of Philosophy in Nursing program of the University of the Philippines in 1988.

A Fellow of the American Academy of Nursing (FAAN) and the Philippine-American Academy of Science and Engineering (PAASE), he is a renowned global scholar with honorary and visiting professorships in universities in Uganda, Thailand, and the Philippines. He is Professor Emeritus of Florida Atlantic University, USA, and Professor of Nursing at University of Tokushima, Japan. The Annual Award of \$750 embodies his commitment to advancing Nursing as a discipline of knowledge and a practice profession, through the integration of technology and caring in nursing.

### Purpose of the Award:

The purpose of the award is to inspire students, practitioners, researchers and faculty members to study and advance the integration of technology and caring in nursing from the perspective of the *Theory of Technological Competency as Caring in Nursing*.

#### Eligibility Criteria:

- Applicant must be an active student, practitioner, researcher, or faculty member pursuing
  the study of caring facilitated by the Theory of Technological Competency as Caring in
  Nursing.
- Applicant must possess a body of work appropriate to his/her role reflecting a
  commitment to the study of caring and technology in contemporary practice within a
  local, regional, national, or international context.

#### **Process and Expectations:**

- The applicant submits an Application Packet with the following contents:
  - A one-page paper describing the applicant's advancing scholarship from the perspective of the Theory of Technological Competency as Caring
  - o A copy of the accepted abstract submitted for a podium or paper presentation.
  - o A separate cover page with:
    - applicant's name, credentials, and institution/organization.
    - contact information, including physical address, phone number, email address.
  - o If the applicant is a student, a reference letter on official school stationery from the Dean and/or a faculty member of the same College/University of the student, who is familiar with the student's scholarship.
  - Submit Application to the IAHC Scholarship and Award Committee @ scholarships@humancaring.org.

#### Post Award Responsibilities

- At presentations or on publications, funded research and scholarly works should indicate that it is "Funded in part by The Vicente Teves Locsin, Jr. Award for scholarship advancing the theory of Technological Competency as Caring in Nursing."
- Applicant must register for the annual IAHC conference to assure proper processing and recording of participation. Please indicate on the registration form that you are an award recipient.
